# **Contest Rules**

These contest rules are specific to the above contest conducted by Entercom Texas, LLC d/b/a KKMJ (collectively, the "Station"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this contest as well. #### How to Enter
