

Sandals Trip-A-Day National Contest Official Rules

These contest rules are specific to the above contest conducted by Audacy Operations, Inc. (the “**Contest Administrator**”) and its certain affiliated companies and radio stations listed on Attachment A to these rules (each, a “**Participating Station**” and collectively, the “**Participating Stations**”). A copy of these specific contest rules and the Participating Stations’ general contest rules are available on the contest rules page of each of the Participating Station’s websites listed on Attachment A to these rules. **As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific contest rules and the Participating Stations’ general contest rules will not be available at the Participating Stations’ studios.**

Notwithstanding any provision of any Participating Station’s general contest rules to the contrary, these official contest rules shall govern this particular contest in the event of any conflict.

Listeners of any Participating Station, and visitors to any Participating Station website listed on Attachment A may enter and potentially win this contest.

Who Can Enter

With a positive test result the guest remains isolated in their room until the release criteria of the specific jurisdiction are satisfied. If negative, the guest will be free to enter and enjoy all the resort. Consultation charges will be waived. If you develop symptoms after leaving the resort, see a doctor right away and advise the resort. Sandals Resorts reserves the right to implement other health, safety, and COVID-19 protocols as the need arises. All guests shall further acknowledge and agree that they are fully aware of the contagious nature and effects of Covid-19 and voluntarily assume that risk and responsibility and further agree that they will release, indemnify and hold harmless Unique Travel Corp and Sandals Resorts, and each of their respective parent companies, affiliates, subsidiaries insurers, directors, officers, employees, agents, successors, assigns, and representatives, against any claims and/or damages whatsoever, including legal fees relating to any infection, transmission, health condition influenced or otherwise impacted or any complication or/by Covid-19.
