

**2019 WSTR “Jenn & Friends \$10,000 Give Back Giveaway Contest”
Official Rules**

These Contest rules are specific to the above Contest conducted by Entercom Georgia, LLC d/b/a WSTR collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific Contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific Contest rules and the Station’s general contest rules are available at the Station’s studio at 210 Interstate North Circle, Suite 600, Atlanta, GA. 30339 during regular business hours and on the Station’s website at www.star941atlanta.com/rules. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.**

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the “Jenn & Friends \$10,000 Give Back Giveaway” (the “**Contest**”).
2. This Contest will give Atlanta area school organizations (*as defined in Section 3 below*) the opportunity to participate for the chance to win a donation to their Eligible School, provided by Delta Community Credit Union, by executing a community service project that Station deems best illustrates the theme of “kids helping kids.”
3. For the purposes of this Contest:
 - a. “**Eligible School**” means a state-accredited public, private or charter educational institution that matriculates any grade from or combination of grade levels from 1st through 12th grade and is located in one of the following Georgia counties: Baldwin, Banks, Barrow, Bartow, Butts, Catoosa, Carroll, Chattooga, Cherokee, Clarke, Clayton, Cobb, Columbia, Coweta, Dade, Dawson, DeKalb, Douglas, Elbert, Fannin, Fayette, Floyd, Forsyth, Franklin, Fulton, Gilmer, Gordon, Greene, Gwinnett, Habersham, Hall, Hancock, Haralson, Hart, Heard, Henry, Jackson, Jasper, Jones, Lamar, Lincoln, Lumpkin, Madison, McDuffie, Meriwether, Monroe, Morgan, Murray, Newton, Oconee, Oglethorpe, Paulding, Pickens, Pike, Polk, Putnam, Rabun, Rockdale, Spalding, Stephens, Taliaferro, Towns, Troup, Union, Upson, Walker, Walton, Warren, White, Whitfield, and Wilkes (each an “**Eligible School**”). Homeschools (whether home-based or collaborative) and online schools are not eligible for this Contest.
 - b. An “**Organization**” is defined as an Eligible School sponsored and supervised group containing no less than two (2) students who are currently enrolled in the Eligible School.
 - c. “**Representatives**” shall mean Eligible School Organization directors who are authorized representatives of the Eligible School (which could be coaches, advisors, principals, superintendents, administrators, directors, teachers or any similar member of a school’s faculty or staff appointed to oversee an Organization. Representatives must be employees or school-authorized volunteers, not students or parents, of the Eligible School for which they are submitting an Entry, and 18 years of age or older.
4. Representatives may enter this Contest from 6:00am (ET) on Monday, August 12, 2019, until 5:30pm (ET) on Friday, November 1, 2019 (the “**Entry Period**”) by submitting a type-written essay of no more than five (5) pages describing your Organization’s service project, including the timeline of the project, approximately how many Organization, Eligible School and/or community members participated, and the way in which the service project affected the community and reflects “youth helping youth” (“**Essay**”) in one of the two following ways (Essay collectively with all other materials described below for selected method of entry, as applicable, an “**Entry**”) in one of the following two ways:
 - a. **MAIL OR PERSONAL DELIVERY:** Submit the following by mail, courier or dropped off in person at the above address during regular business hours (9:00am (ET) - 4:00pm (ET), Monday - Friday, excluding holidays) to WSTR, Attn: Jenn & Friends \$10,000 Give Back Giveaway, 210 Interstate North Circle, Suite 600, Atlanta, GA 30339.
 - i. A completed official Entry and Certification of Consent Form (“**Certification**”) available for download online at www.star941atlanta.com/contests and attached to these Contest rules as ATTACHMENT A;
 - ii. Your Essay; and
 - iii. The Representative submitting the Entry is also responsible for obtaining written permission from ALL students featured in photos or videos (or from a parent or legal guardian if the student is under 18 years of age) consenting to submission of the Entry and participation in the form of the Release and Consent form attached to these rules as ATTACHMENT B;
 - iv. **OPTIONAL:** photo or video files of the event may be included on a total of one CD or one thumb drive (this is optional);
 - v. All Entries submitted by mail or personal delivery must be complete and submitted together in one envelope or package (for example, entry forms submitted in a different package than an Essay

will be disqualified and thumb drives submitted in a different envelope or on a different day from the entry form and Essay will have the thumb drive discarded and not considered as part of the Entry).

- b. ONLINE ENTRY: In order to enter electronically, all of the following steps must be completed by the Representative during the Entry Period:
 - i. Complete and submit an online entry form for this Contest on the www.star941atlanta.com/contests page, including the Essay (please note that online entries may require text only and may not include the opportunity to insert any graphics or photos). **Submission of any online entry form in this Contest is only one of two required steps in order to be validly entered in this Contest.**
 - ii. Within two business days (48 hours, excluding weekends) after submitting the above online entry form, the Representative will receive a bounce back e-mail requiring that he/she respond back to that same email and attach the required completed and signed Certification attached hereto as ATTACHMENT A which may be a .pdf, .jpeg, or Word document like a .doc or a .docx), along with supplementary photos (optional) as an e-mail attachment. The Representative submitting the Entry is also responsible for obtaining written permission from ALL students featured in photos or videos (or from a parent or legal guardian if the student is under 18 years of age) consenting to submission of the Entry and participation in the form of the Release and Consent form attached to these rules as ATTACHMENT B.
 - iii. The combined size of all attachments to such email cannot exceed 5MB. Station is not responsible for any failure to receive any email to which the combined size of all attachments exceeds 5MB. Entry in this Contest will not be accepted until email with the Certification is e-mailed back to the Station. Entrants choosing to enter this Contest via online entry methods will be required to create a personal profile via the station's e-mail club. Station is not responsible for any problems that result in a failed or delayed e-mail or any corrupted or unopenable attachment or Certification. Only emails actually received by Station during the Entry Period will be valid for the purposes of this Contest (i.e. date stamps on any entrant or Station email will not be valid, only actual date and time that is was actually available for viewing by Station staff will be considered).
 - iv. Except with respect to online entries (which may be restricted as to inserted non-text materials), the Essay may include photographs, charts, graphs or other information that the Representative believes will best reflect its Organization, the event and its success within those five pages and the theme of "youth helping youth". Station will not be obligated to look at any additional pages or printed materials provided.
5. **Limit one (1) Entry per Eligible School Organization.** Station will only accept the first Entry received. An Eligible School may enter more than one Organization in this Contest and each subgroup within an Organization may be considered a separate Organization (for example, a school's Junior Varsity team would be considered a separate Organization from that same school's Senior Varsity team, even if the same teacher supervises both). The same children/teachers and supervisors may be participants in more than one Entry as long as each Entry is for a different Organization.
6. **By entering this Contest, Representatives represent warrant and covenant that they have obtained permission from all students (or from a parent or legal guardian if the student is under 18 years of age), consenting to submission of the Entry if they are featured in photos or videos of the community service project. BY ENTERING THIS CONTEST AND SUBMITTING AN ENTRY, REPRESENTATIVES REPRESENT TO STATION THAT THE USE AND DISTRIBUTION OF SUCH ENTRY WILL NOT VIOLATE OR INFRINGE UPON THE RIGHTS OF ANY THIRD PARTY, INCLUDING, WITHOUT LIMITATION, COPYRIGHTS OF OTHERS.**
7. **By entering this Contest, Representatives understand and agree that Station may elect to use any Entry submitted for entertainment purposes on-air. Representatives forever release and waive any right to make any claim against Station or any Contest sponsors, prize providers, or other participant ("Released Parties") with respect to any disparaging comment made on-air about such entrant's Entry. An announcement made regarding an Organization's Entry in the Contest, used as an example on the air, has no bearing on the likelihood of the organization to be a finalist or a Grand Prize winner of the Contest.**
8. **By entering this Contest, Representatives and the Eligible School which Representative represents agrees to indemnify, defend and hold harmless the Released Parties from and against any claims, expenses proceedings, suits, actions or costs (including costs from reasonable attorneys' fees) of any kind or nature incurred by the Released Parties on account of a breach by Representative of any of their representations, warranties, covenants or agreements as a result of Representative's participation in the**

Contest. Station reserves the right to disqualify an Entry in its sole discretion at any time during this Contest if Station believes such representations are false.

How to Win

9. Following the conclusion of the Entry Period (*as set forth in Section 4 above*) and prior to Monday, November 11, 2019, Station will select the up to five (5) Entries it likes best (based upon the scope of the service project, how many people the service project served, how many community members / organization members / other students it involved, and any other lawful criteria deemed desirable to Station as determined in the Station's sole discretion) to continue in this Contest, subject to verification of eligibility and compliance with the Contest rules (each, a "Finalist" and collectively, the "Finalists"). **All decisions by Station relating to and including the selection of Finalists in this Contest are final and may not be appealed. There will be up to, but in no event more than, five (5) Finalists in this Contest.**
10. Once selected, Station will contact the Representative of each Finalist in order to attempt to verify eligibility, obtain copies of parental and adult consents (referred to in the Certification), and schedule an on-air interview (live or pre-recorded) for broadcast the week of November 11, 2019 through November 15, 2019. Finalist need not participate in the interview in order to be a Finalist and continue as a Finalist in this Contest. Station reserves the right to disclose and produce information about the Finalist's Entry for on-air announcements during the week of November 11, 2019 through November 15, 2019.
11. Beginning at approximately 7:00am (ET) on Monday, November 11, 2019, and each weekday thereafter at approximately 7:00am (ET) for the next four days, (Tuesday, November 12, 2019; Wednesday, November 13, 2019; Thursday, November 14, 2019; and Friday, November 15, 2019), the Station will reveal each of the up to five (5) Organizations selected by Station to continue in this Contest as Finalists. Station may also elect, but will not be obligated, to share or post Entry materials provided by Representative on-air or online for some or all of the Finalists (in Station's sole discretion), which Entry materials may be edited as Station sees fit.
12. On or about November 8, 2019, Station management and/or other Station selected judges will review the five (5) Finalists and select one (1) Grand Prize winner based on any lawful criteria determined by Station in its sole discretion. The Station will select the Grand Prize winner of the Contest, subject to verification of eligibility and compliance with the Contest Rules (the "**Grand Prize Winner**"). Station will contact the Representative of the potential Grand Prize Winner's Eligible School on or before November 16, 2019. Station will request that the Representative not share with any students, parents or faculty the fact that their school won any prize in this Contest until after a Station public announcement or the "pep rally" described below. **Station may elect not to publicly announce the Grand Prize Winner until after the "pep rally" although such information may be disclosed by third parties that Station has no ability to control. In all events, the Grand Prize Winner will be publicly announced by Station on-air no later than December 2, 2019.**
13. On or about November 8, 2019, Station management and/or other Station selected judges will review the four (4) remaining Finalists and select one (1) Runner-Up Prize winner based on any lawful criteria determined by Station in its sole discretion. The Station will select the Runner-Up Prize winner of the Contest, subject to verification of eligibility and compliance with the Contest Rules (the "**Grand Prize Winner**") from the four (4) remaining Finalists after the Grand Prize winner is selected. Station will contact the Representative of the potential Runner-Up Prize Winner's Eligible School on or before November 16, 2019. **The Runner-Up Prize Winner will be publicly announced by Station on-air no later than December 2, 2019.**
14. Station reserves the right to disqualify an Entry or Finalist at any point in the competition if it determines that an Entry or Finalist is ineligible or violated the Contest rules as determined by Station in its sole discretion.

Prize(s)

15. **Grand Prize:** Station will award one (1) Grand Prize of \$10,000 (the "**Grand Prize**") in this Contest to the Eligible School whose Organization was the Grand Prize Winner in this Contest, subject to verification of eligibility and compliance with these Contest rules. The Grand Prize check will be presented by Station to the Eligible School preferably at a mutually agreeable day and time prior to Thanksgiving break at the Organization's Eligible School with a School- organized "pep rally" style event or other mutually agreed upon check presentation event. If the Eligible School is unable or unwilling to host a "pep rally" or similar check-presentation event on a mutually agreed upon day and time, Station reserves the right to require that the Representative or school principal, or district's Superintendent pick up the check after November 18, 2019 but prior to January 24, 2020.
16. **Runner-Up Prize:** Station will award up to one (1) \$2000 Runner-Up prize (the "**Runner-Up Prize**") in the Contest to one (1) eligible Finalist who does not win the Grand Prize. Such Runner-Up Prize to be available for pick-up on

or around Monday, November 18, 2019 by the Representative or principal, or district's Superintendent at the Station's studios at 210 Interstate North Circle, Suite 600, Atlanta, GA 30339, during regular business hours, (9:00am (ET)-4:00pm (ET), Monday-Friday excluding holidays) on Monday, November 18, 2019 within 90 days of winning. Check will not be mailed, unless otherwise determined by the Station.

17. **Finalist Prizes:** Station will award up to three (3) \$1000 finalist prizes (the "**Finalist Prizes**") in the Contest to the Eligible Schools of each of the four (3) Finalists who do not win the Grand Prize or the Runner-Up Prize. Such Finalist Prizes to be available for pick-up on or around Monday, November 18, 2019 by the Representative or principal, or district's Superintendent at the Station's studios at 210 Interstate North Circle, Suite 600, Atlanta, GA 30339, during regular business hours, (9:00am (ET) -4:00pm (ET), Monday-Friday excluding holidays) on Monday, November 18, 2019 within 90 days of winning. Check will not be mailed, unless otherwise determined by the Station.
18. Checks will not be mailed, unless otherwise determined by the Station. Winning Eligible Schools must provide Station with a copy of its tax id form and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting a prize in this Contest. **Station has no obligation to any Finalist, Runner-Up Prize Winner, or to the Grand Prize Winner regarding the application of the check funds by the Eligible School, which includes but is not limited to how the funds are used by the Eligible School and the timing of the distribution of the funds by the Eligible School.**

Sponsor(s)

19. The sponsor of this Contest is Entercom Georgia, LLC. All prizes provided by Delta Community Credit Union.

Other Rules Applicable to this Contest

20. Station retains possession of all Entries. The Released Parties retain all rights to use any Entries, descriptions of service projects, essays, photos, videos, or any part thereof, indefinitely in any promotions including but not limited to on-air usage without any compensation to Representatives, Eligible Schools, Organizations or any third parties. The aforementioned stipulations apply to all winning and non-winning Entries. The Released Parties shall not be responsible for any costs associated with submitting any Entry, any costs arising out of participating in the Contest, or for the failure of any Entrant to adhere to the official Contest rules. Released Parties are not responsible for technical problems that may impact the ability of CD Entries to play in a CD player or a thumb drive to be inserted into a computer and files extracted.
